The Grand Jurors of Maricopa County, Arizona, accuse MISTY LEE WILKE, on May 10, 2016, charging that in Maricopa County, Arizona:

COUNT 1:

MISTY LEE WILKE, on or about April 29, 2016, using a Ford Mustang, a deadly weapon or dangerous instrument, intentionally, knowingly or recklessly did cause a physical injury to Joseph Michael Valva, in violation of A.R.S. §§ 13-1203, 13-1204, 13-3601, 28-3304, 28-3001, 28-3004, 28-3005, 28-3315, 13-701, 13-702, and 13-801.

COUNT 2:

MISTY LEE WILKE, on or about April 29, 2016, intentionally, knowingly or recklessly did cause physical injury to Joseph Michael Valva by any means of force, which caused a fracture of any body part of Joseph Michael Valva, in violation of A.R.S. §§ 13-1203, 13-1204, 13-3601, 28-3304, 28-3001, 28-3004, 28-3005, 28-3315, 13-701, 13-702, and 13-801.

COUNT 3:

MISTY LEE WILKE, on or about April 29, 2016, without premeditation, intentionally did attempt to cause the death of Joseph Michael Valva, in violation of A.R.S. §§ 13-1001, 13-1101, 13-1104, 13-3601, 13-710, 13-701, 13-702, and 13-801.

COUNT 4:


MISTY LEE WILKE, on or about April 29, 2016, operated a vehicle that was involved in an accident resulting in a serious injury to Joseph Michael Valva and did fail or refuse to remain

at the scene, and failed to fulfill the requirements of A.R.S. §28-663, in violation of A.R.S. §§ 28-661, 28-3001, 28-3304, 28-3305, 28-3315, 13-3601, 13-701, 13-702, and 13-801.
