B1. Probable Cause Statement

ON 12-15-16 AT APPROXIMATELY 0241 HOURS, OREN AHARON COHEN WAS ARRESTED AT 9010S PRIEST DR, TEMPE, AZ, FOR 2ND DEGREE BURGLARY, AGGRAVATED ASSAULT AND KIDNAP-PING. OREN ENTERED AN APARTMENT AT THE LISTED LOCATION THROUGH UNKNOWN MEANS AND WAS DISCOVERED IN THE LIVING ROOM HOLDING A 2 YEAR OLD FEMALE THAT WAS UNKNOWN TO HIM. AT THE TIME THE INCIDENT OCCURRED, THE VICTIM'S FATHER WAS WOKEN UP BY THE SOUNDS OF THE 2 YEAR OLD CRYING. AFTER EXITING HIS BEDROOM TO INVESTIGATE WHY THE 2 YEAR OLD WAS CRYING, THE VICTIM'S FATHER DISCOVERED OREN IN THE LIVING ROOM HOLDING THE 2 YEAR OLD FEMALE CHILD ON OREN'S LAP. THE VICTIM'S FATHER RE-PORTED THAT OREN'S PANTS WERE SLIGHTLY PULLED DOWN AND HIS BUTTOCK WAS EXPOSED. ONCE OREN OBSERVED THE VICTIM'S FATHER IN THE LIVING ROOM, OREN THREW THE VICTIM ON THE COUCH AND TOLD THE VICTIM'S FATHER, "I'M YOUR FRIEND" ALTHOUGH THE VIC-TIM'S FATHER ADVISED HE HAS NEVER SEEN OREN BEFORE. AS OREN ATTEMPTED TO LEAVE THE APARTMENT, THE VICTIM'S FATHER TRIED TO DETAIN OREN AND OREN ATTEMPTED TO FIGHT THE VICTIM'S FATHER. THE MOTHER OF THE VICTIM WENT TO THE LIVING ROOM AND DISCOVERED THE STRUGGLE AND CALLED 911. DURING THE STRUGGLE THAT LASTED APPROX-IMATELY 10 MINUTES, OREN WAS ABLE TO ESCAPE FROM THE APARTMENT AND THE VICTIM'S FATHER PURSUED OREN OUT OF THE APARTMENT, DOWN THE STAIRS AND INTO THE PARKING LOT WHERE THE VICTIM'S FATHER WAS ABLE TO SUCCESSFULLY DETAIN OREN RESPONDING TEMPE POLICE OFFICERS ARRIVED. ONCE TEMPE POLICE OFFICERS ARRIVED ON-SCENE, OREN REFUSED COMMANDS AND ULTIMATELY WAS TASED BY OFFICERS AT WHICH POINT OREN WAS SUCCESSFULLY TAKEN INTO CUSTODY. THE VICTIM'S FATHER INDICATED THAT WHEN HE DIS-COVERED OREN WITH THE 2 YEAR OLD CHILD, SHE WAS STILL WEARING THE PAJAMAS THAT SHE WAS WEARING WHEN HE PUT HER TO BED AND SHE WAS STILL WEARING A DIAPER WHEN THE ORIGINAL INVESTIGATION OCCURRED. DURING THE IMMEDIATE INVESTIGATION AT THE APARTMENT, OREN'S SHOES WERE LOCATED INSIDE THE 2 YEAR OLD VICTIM'S BEDROOM, HIS COAT WAS WEDGED BETWEEN HER MATTRESS AND THE WALL AND HIS PASSPORT WAS ON THE FLOOR NEAR THE FOOT OF THE VICTIM'S BED. IN ADDITION, EVIDENCE SUGGESTED THAT OREN USED THE RESTROOM ACROSS FROM THE VICTIM'S BEDROOM AND ALSO REMOVED AND DRANK ORANGE JUICE FROM THE REFRIGERATOR THAT WAS FOUND ON THE TABLE. DURING A FORENSIC INTERVIEW WITH THE 2 YEAR OLD VICTIM, SHE ADVISED THAT THE "BAD MAN" GAVE HER AN "OUCHIE" AND POINTED TO HER BUTTOCKS. THE VICTIM WAS UNABLE TO AR-TICULATE ANY ADDITIONAL DETAILS DUE TO HER AGE. DURING A MIRANDIZED INTERVIEW WITH OREN, HE INDICATED HE WAS VISITING AND DRINKING WITH A FRIEND WHO LIVES IN THE SAME APARTMENT COMPLEX. ACCORDING TO OREN, HE WAS EXTREMELY INTOXICATED AND HAD VERY LITTLE RECOLLECTION OF THIS INCIDENT. OREN STATED HE REMEMBERED BEING IN A DARK ROOM AND SEEING A "MIDGET." WHEN ASKED TO DESCRIBE THE "MIDGET," OREN PROVIDED A DESCRIPTION OF THE 2 YEAR OLD VICTIM. OREN SAID HE REMEMBERED THE PERSON WALKING AND SAID HE "PLAYED" WITH THE "MIDGET" AND POSSIBLY PICKED HER UP BUT COULD NOT RECALL SPECIFIC DETAILS. OREN ADVISED WITH 100% CERTAINTY THAT HE DID NOT PERFORM OR ENGAGE IN ANY SEXUAL ACTS WITH THE VICTIM OF THIS INCIDENT. ONCE IT WAS RELAYED TO OREN THAT THE VICTIM IN HIS INCIDENT WAS A 2 YEAR OLD FE-MALE, HE BECAME VERY UPSET AND BROKE DOWN CRYING. OREN SAID HE WOULD NEVER HURT A CHILD AND DOES NOT REMEMBER THE DETAILS OF THIS INCIDENT BECAUSE HE WAS "BLACK OUT DRUNK." OREN SAID HE SOMETIMES HE DOES "STUPID SHIT" WHEN HE IS DRINKING AND PROVIDED EXAMPLES OF TRYING TO "PICK UP GIRLS AT BARS" AND TRYING TO "FIGHT MALES." OREN AGREED THAT HIS ACTIONS DESERVED PUNISHMENT BUT HE INDICATED HE WANTED TO RETURN TO ISRAEL AS A RESULT OF THIS INCIDENT. OREN IS NOT A CITIZEN OF THE UNITED STATES AND IS LEGALLY IN THE UNITED STATES FROM ISRAEL WITH A VAL-ID PASSPORT. OREN WAS BOOKED INTO THE TEMPE CITY JAIL WHERE HE WAS LATER TRANS-PORTED TO THE 4TH AVE JAIL TO SEE A JUDGE FOR HIS CHARGES.
